NOTICE

Further to our notice dated 01.03.2026 released on the official IBPS website www.ibps.in, provisional allotment exercise from reserve list under CRP-CSA-XV has been done, except for the UT of Chandigarh in compliance of order dated 12.02.2026 passed in LPA No. 408/2026 (Punjab National Bank Vs. Manjeet Vs. Ors. before the Hon'ble High Court of Punjab & Haryana at Chandigarh) and Writ Petition No. 38097/2025 (Manjeet Vs. IBPS & Ors.) before the Hon'ble High Court of Punjab & Haryana at Chandigarh, based on the actual vacancies provided by the Participating Banks. Provisionally allotted candidates are being intimated individually at the email address and mobile number registered with IBPS at the time of online registration for CRP-CSA-XV.

The said provisional allotment under Reserve List has been done based on merit-cum-preference keeping in view the spirit of various guidelines issued by Govt. of India/ Others from time to time, administrative exigency etc.

In the event of two or more candidates having obtained the same score, merit order is decided as per date of birth (the candidate senior in age is placed before the candidate junior in age).

Please note:

1. No change in the data already registered by the candidate in the online application form is possible.
2. The decision of IBPS in said provisional allotment of Banks is final and binding upon the selected candidates. However, IBPS reserves the right to cancel, reallot Bank-wise allocation/change the process depending upon exigencies or otherwise. The candidates however, shall have no right to demand re-allotment on any grounds and allotment once done shall be final and binding on the candidates.
3. The said provisional allotment from reserve list is subject to the candidate fulfilling the criteria for Participating Banks including proficiency in Local Language of the State/UT and identity verification to the satisfaction of the allotted Bank. This does not constitute an offer of employment. In case it is detected at any stage of the recruitment process that, the candidate does not satisfy the eligibility criteria his/her candidature/ chance in the process shall stand forfeited.

4. Offer of appointment including terms and conditions, formalities for verification, joining etc. will be issued by the allotted Participating Bank in due course. Candidates may approach the respective Allotted bank only after hearing from the said bank. Offer of appointment is solely the decision of the Participating Banks and shall be final and binding. IBPS has no role to play in this respect. Please note that even after issuing of appointment letter by the concerned Allotted Bank, if appointment letter is cancelled/revoked due to want of certificates or mismatch in Biometric Thumb Impression, Aadhaar Data and photograph or for any other reason whatsoever, IBPS shall not be held liable.
5. If the candidate does not avail the offer/ appointment from the allotted Participating Bank, his/her candidature/ chance in the process shall stand forfeited.
6. The State/UT wise and category wise minimum scores (Main Exam Scores out of 100) for the present round of allotment is indicated in the Annexure I.
7. The list of candidates provisionally allotted under this exercise (State / UT wise) shall be displayed on authorised IBPS website on or before 15.07.2026. This however does not guarantee offer of employment. Decision of the Participating Bank shall be final and binding.
8. In the event of some or any of the Participating Banks providing further vacancies within validity period of CRP CSA XV or until a fresh provisional allotment is made, whichever is earlier, further provisional allotment from the Reserve List may be carried out.
9. No correspondence will be entertained from the candidates about allotment status and/ process.
10. Provisional allotment however is subject to Court order, if any.
