NOTICE

This is in continuation to Notice dated 02.03.2026.

Provisional allotment under CRP CSA-XV for UT of Chandigarh has been done in light of order dated 16.07.2026 passed in Writ Petition No. 38097/2025 (Manjeet Vs. IBPS & Ors.) before the Hon'ble High Court of Punjab & Haryana at Chandigarh.

The Provisional Allotment is based on the category-wise vacancies for 2026-27 for Customer Service Associates as furnished by the Participating Banks (details vide Annexure A) subject to availability.

Candidates for the UT of Chandigarh, can view their result status on official IBPS website www.ibps.in by entering their Registration Number or Roll Number and Date of Birth or Password.

Please note:

1. No change in the data already registered by the candidate in the online application form is possible.
2. The said provisional allotment has been done based on merit-cum-preference keeping in view the spirit of Govt. Guidelines on reservation policy, various guidelines issued by Govt. of India /Others from time to time, administrative exigency etc.
3. **A candidate belonging to reserved category, selected on the basis of norms as applicable to General Category, has been treated at par with a General category candidate. Such own merit candidates belonging to reserved categories who are provisionally allotted under unreserved (General) category will not be adjusted against a reserved post. However, their original category as registered in the online registration will remain unchanged.**
4. In the event of two or more candidates having obtained the same score, merit order is decided as per date of birth (the candidate senior in age is placed before the candidate junior in age), as per the prevailing practice.
5. The provisional allotment is subject to the candidate fulfilling the criteria for Participating Banks including proficiency in Local Language of the State/UT and identity verification to the satisfaction of the allotted Bank. The Participating Bank reserves the right to cancel the

candidature on account of not qualifying the local language proficiency test/ not having required certificate. Decision of the Participating Banks shall be final and binding upon the candidates. This does not constitute an offer of employment. In case it is detected at any stage of the recruitment process that, the candidate does not satisfy the eligibility criteria, his/her candidature/ chance in the process shall stand forfeited. Provisionally allotted candidates may note the following points related to LLPT as per Clause H of detailed notification of CRP CSA XV:

- The candidates applying for vacancies of a particular State/UT, should be proficient in (reading, writing, speaking and understanding) the specified / opted local language of that State/UT (mentioned in the list provided for each State/ UT as per Annexure III).
 - Candidate has to opt for ONE language at the time of online application for local language test from the list provided for each State/ UT as per Annexure III.
 - Candidates who produce 10th standard or above mark sheet/ certificate evidencing having studied the specified/ opted local language will not be required to undergo the language test.
 - The test will be conducted after qualifying the Online Main examination/ Provisional Allotment but before joining the Bank.
 - The test for knowledge of specified/ opted local language will be conducted as a part of selection process by an independent body or by the Bank and will be marks based and qualifying in nature.
 - Candidates who fail to qualify this test will not be offered appointment and will be disqualified from the process.
6. Offer of appointment including terms and conditions, formalities for verification, joining etc. will be issued by the allotted Participating Bank in due course. Decision of Participating Banks shall be final and binding.
 7. The recruitment process/ appointment is solely the purview of the Participating Banks and shall be final and binding. IBPS has no role in this regard. Please note that even after issuing of appointment letter by the concerned Participating Bank, if appointment letter is cancelled/ revoked due to want of certificates or mismatch in Biometric Thumb Impression, Aadhaar Data and Photograph or for any other reason whatsoever, IBPS shall not be held liable.
 8. If the candidate does not avail the offer/ appointment from the allotted Participating Bank his/her candidature/ chance in the process shall stand forfeited.
 9. A list of candidates (in Registration Number order) provisionally allotted will be displayed on official IBPS website, www.ibps.in on or before 16.08.2026. However, this does not guarantee offer of employment. Decision of Participating Banks shall be final and binding.
 10. A **reserve list** to the extent of approximately 30 percent of the vacancies under each category has been kept, subject to the availability of candidates, as per Government of India directives. This does not guarantee provisional allotment to/recruitment by the Participating Bank(s). In the event of Participating Banks providing further vacancies, within the validity period of the

Reserve List at different intervals, provisional allotment may be carried out three to four times for the candidates in the reserve list, based on the vacancies provided by some or any of the Participating Banks at different intervals during the period. However, if no vacancy is furnished by the Participating Banks owing to exigencies or otherwise during the validity period, the candidates under the reserve list will not be considered for provisional allotment. The reserve list will expire automatically on the day which is one year after the date of Provisional Allotment or until a fresh provisional allotment is made, whichever is earlier, with or without any notice.

11. **Candidates who are not provisionally allotted or are not in the reserve list will not be considered for any further process under CRP- CSA-XV for vacancies of 2026-27.**
12. The State/UT wise and category wise maximum and minimum scores (Online Main Examination scores out of 100) for the provisional allotment and reserve list are indicated in Annexure B.
13. The decision of IBPS in provisional allotment of Banks is final and binding upon the selected candidates. However IBPS reserves the right to cancel, reallocate Bank-wise allocation/change the process depending upon exigencies or otherwise. The candidates however, shall have no right to demand re-allotment on any grounds and allotment once done shall be final and binding on the candidates.
14. No correspondence will be entertained from the candidate about allotment status and/ process.
15. Provisional allotment is subject to Court order, if any.
