**NOTICE**

Provisional Allotment under Reserve List is being made for the posts of Officer Scale I, II and III based on the actual reported vacancies by the respective RRBs in each category and posts, subject to availability of candidates. The list of RRBs for which Provisional Allotment under Reserve List has been made is attached as Annexure I for Officer Scale I and Annexure II for Officers Scale II & III.

Provisionally Allotted candidates are being intimated individually at the email address and mobile number of candidates registered with IBPS at the time of online registration for CRP RRBs-XIV.

For Officers Scale I, the said provisional allotment under Reserve List has been done based on merit, keeping in view the spirit of Govt. Guidelines on reservation policy, various guidelines issued by Govt. of India/Others from time to time, administrative exigency, etc.

For Officers Scale II and III, the said provisional allotment under Reserve List has been done based on merit-cum-preference, keeping in view the spirit of Govt. Guidelines on reservation policy, various guidelines issued by Govt. of India/Others from time to time, administrative exigency, etc.

In the event of two or more candidates having obtained the same score, merit order is decided as per date of birth (the candidate senior in age is placed before the candidate junior in age), as per the prevailing practice.

Please note:

1. No change in the data already registered by the candidate in the online application form is possible.
2. The decision of IBPS for said provisional allotment of RRBs is final and binding upon the selected candidates. However, IBPS reserves the right to cancel, reallocate RRB-wise allocation/change the process depending upon exigencies or otherwise. The candidates however, shall have no right to demand re-allotment on any grounds and allotment once done shall be final and binding on the candidates.
3. The said Provisional Allotment is subject to the candidate fulfilling the criteria for the Regional Rural Bank and identity verification to the satisfaction of the allotted RRB. This does not constitute an offer of employment. In case it is detected at any stage of

the recruitment process that the candidate does not satisfy the eligibility criteria, his/her candidature/ chance in the process shall stand forfeited.

4. Offer of appointment, terms and conditions, formalities for verification, joining etc. will be issued by the allotted RRB in due course. Decision of the RRB shall be final and binding. The recruitment process/ appointment is solely the purview of the RRBs and shall be final and binding. IBPS has no role in recruitment. The concerned Regional Rural Bank has the sole discretion to issue the appointment letter or otherwise. Please note that even after issuing of appointment letter by the concerned Regional Rural Bank if appointment letter is cancelled/revoked due to want of certificates or mismatch in Biometric Thumb Impression/ Aadhaar or photograph or for any other reason whatsoever, IBPS shall not be held liable.
5. If the candidate does not avail the offer/ appointment from the allotted RRB his/her candidature/ chance in the process shall stand automatically forfeited.
6. Bank wise (State wise) list of candidates (post-wise in Registration Number order) provisionally allotted on the basis of marks will be displayed on IBPS official website [www.ibps.in](http://www.ibps.in) . However, this does not guarantee offer of employment. Decision of the RRBs shall be final.
7. Provisional allotment from the Reserve list for the above posts for the remaining RRBs will be made in Phase II subject to respective RRBs completing their process of appointment and communicating further vacancies for Reserve List to IBPS.
8. No correspondence will be entertained from the candidates about provisional allotment status and/ process.
9. Provisional allotment however is subject to Court order, if any.
